- The participant should submit their abstract in pdf format through email or in a pre-defined template on website. Pleasedo not submit the password protected file.
- 03
- The abstract should be of 225-450 words. The participant can submit and present their abstract in English and Hindi language
- 04
- The abstract should align to the abstract competition themes mentioned in the email.

- Plagiarism is strictly forbidden, and abstracts found to be plagiarized will be rejected
- 06
- The participants must ensure that the submitted abstract has not been published before in any language at any forum
