The participant should submit their abstract in pdf format through email or in a pre-defined template on website. Please do not submit the password protected file.

03

The abstract should be of 225-450 words. The participant can submit and present their abstract in English and Hindi language

04

The abstract should align to the abstract competition themes mentioned in the email.

05

Plagiarism is strictly forbidden, and abstracts found to be plagiarized will be rejected

06

The participants must ensure that the submitted abstract has not been published before in any language at any forum

07

The participant should provide the below **mentioned fields while submitting their abstract** through email:

- Title of abstract:
- Author(s):
- Contact no.:
- Organization name:
- Scope and objective of the abstract (25-75 words)
- Approach and methodology including the process/procedures adopted (75-100 words)
- Results, observations and conclusion of abstract (100-200 words)
- Potential value-add enabled by the abstract in providing novel or additional information to the existing application or literature (25-75 words)

Participants from academic institutions whose abstract are selected for presentation at the conclave will be provided accommodation facility in Delhi-NCR

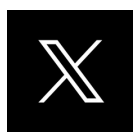
